FEES & CHARGES

1. Interment Fees

(a) Foetus, still born or child whose age at death does not exceed 1 month (1, 2 or 3 coffin depth)	Free of charge
(b) Child whose age at death exceeds 1 month but does not exceed 16 years	£225.00
(c) Organs and other body parts removed in the course of a post-mortem examination of a body	Free of charge
(d) A person whose age at death is 17 years and above	
1 coffin	£450.00
2 coffins	£480.00
3 coffins	£510.00
(e) Re-open grave	
Single depth	£495.00
Double depth	£536.00
(f) Interment of cremated remains	£210.00
(g) Interment of cremated remains of a child up to 16 years old	£105.00
(h) Witness interment of cremated remains	£25.00

Note: When 2 interments take place simultaneously in the same grave, only half of the interment fee is payable for the second interment.

2. Exclusive Rights of Burial (for South Staffordshire Residents)

Payment for the Exclusive Right of Burial to a maximum number of three interments for a period of 50 years with the option to extend on the terms then prevailing. When purchasing this right the customer is also entitled to a temporary memorial.

(d)	Excess charge for a late notice of coffin size	£100.00
(e)	Additional charge for incorrect information supplied by funeral director, e.g. coffin size	£60.00

6. Premium Fees (for Non-Residents)

Families of deceased who were non-residents of South Staffordshire who wish their relatives to be interred at Sytch Lane Cemetery will be required to pay a premium fee in order to preserve burial space for residents of South Staffordshire.

*** All fees are trebled for those residing outside the District ***

(a) Exemptions

Where evidence is provided that the deceased lived in the District for the majority of their life but took up a place in full-time care outside the District within two years of their death, the premium fee will be waived.
