### 3. DELIVERY OF NOMINATION PAPERS

Nomination papers must be delivered to the Returning Officer at Customer and Electoral Services, Council Offices, Codsall, South Staffordshire, WV8 1PX, on any day after the date of this notice between the hours of 8.45am and 5pm on Monday to Friday, but not later than **Noon on Wednesday 4<sup>th</sup> April 2007**.

### 4. POLL

If the election is contested, polling will take place on **Thursday 3<sup>rd</sup> May 2007**.

### 5. ABSENT VOTING

Electors and their proxies should take note that applications to vote by post must reach the Electoral Registration Officer at the above address by **5pm on Wednesday 18<sup>th</sup> April 2007** if they are to be effective for this election. This includes electors or their proxies who wish to make alterations to their existing arrangements on a permanent basis or who wish to make separate application for their ballot paper to be sent to a different address for this particular election.

Applications to vote by proxy must reach the Electoral Registration Officer by no later than **5pm on Wednesday 25<sup>th</sup> April 2007**, except in cases where unforeseen illness or incapacity occurs after that time in which case applications may be made up to **5pm on Thursday 3<sup>rd</sup> May 2007**.
