## **South Staffordshire Local Plan Examination**

Action 5.3 – Council to provide list of allocations in the Local Plan that have been carried forward from the adopted development plan, including details of capacity.

The below information has been provided upon the request of the inspectors (action 5.3). It provides details of allocations from the previously adopted 2018 Site Allocations Document [DP2] which are being carried forwards within the Submission plan [CD1]. There are three types of allocations being carried forward:

- 1. Adopted Housing allocations (under Policy SAD2)
- 2. Safeguarded Land (under Policy SAD3)
- 3. Employment Allocations (under Policy SAD5).

Details of these allocations are provided below under the relevant section.

Gypsy and Traveller Pitch allocations being carried forward in the Submission Plan are provided separately under Action 8.3.

## 1. Adopted Housing allocations

There are a number of site which were allocated for residential development under Policy SAD2 of the 2018 Site Allocations Document which did not have planning permission at 1<sup>st</sup> April 2023, which are being carried forward in the Submission Plan under Policy SA3. Details of these sites are provided in Table 1.
